The third meeting of the Mental Health, Wellbeing, and Alcohol and Other Drugs Joint Leadership Group (JLG) was held on Thursday, 8 August 2024. This communique provides all stakeholders with information and outcomes from the meeting.

The JLG provides high level, system-wide, collaborative decision-making, and oversight, to deliver a system that adopts a person and family-centred approach and encapsulates whole of system priorities. This includes the transition to more community-based services that provide prevention and earlier intervention, and diversion away from acute in-patient services. The JLG is accountable for the delivery of key reform priorities including those outlined in the overarching system-wide Mental Health and Alcohol and Other Drugs Strategy 2025-2030 (when completed) in alignment with the Outcome Measurement Framework (when completed).
