## Webinar Event 1

### Stigma as a Barrier

**Presented by:** Workforce Development, Mental Health Commission

**Date:** Tuesday, 4 February 2025 • 10:00am – 12:00pm

**Target audience:** Human service workers working with people who use AOD.

Negative views and attitudes towards people who use AOD creates a significant barrier to individuals accessing support services and health care. This webinar aims to explore stigma, where it comes from, how it is perpetuated, the negative impacts, as well as looking at ways of safely challenging stigma and implementing best practice when working with people who use drugs.

By the end of this webinar, participants will be able to:

- understand the concepts and structures of stigma faced by individuals who use AOD
- describe the attitudes that contribute to AOD stigma
- consider intersectionality and the impact of stigma on people who use AOD
- develop skills to safely challenge stigma utilising best practice, non-stigmatising language and concepts when speaking with or about people who use AOD.

### Alcohol Use During Pregnancy and Fetal Alcohol Spectrum Disorder (FASD) Prevention

**Target audience:** Human service workers with clients of childbearing age, their families, and communities.

This webinar has been planned to coincide with International FASD Awareness Day. We will review foundational concepts for the development and delivery of best-practice FASD prevention, such as:

- contextualising alcohol use in Australia
- complexities associated with alcohol use during pregnancy
- defining FASD
- considering prevention strategies that respond to community strengths and needs.

We will also briefly touch on the Mental Health Commission's FASD Prevention Funding Program.

## Webinar Event 5

### Family and Domestic Violence (FDV) Risk Assessment

**Presented by:** Women's Health Strategy and Programs, North Metropolitan Health Service

**Date:** Tuesday 3 June 2025 • 10:00am – 11:00am

**Target audience:** Human service workers working with people who may be experiencing AOD and/or mental health (MH) issues.

Accessing AOD and/or MH services provides a port of entry for Family and Domestic Violence (FDV) risk assessment. This webinar aims to increase understandings of FDV evidence based high-risk factors and the importance of risk assessments in the prevention of FDV-related harm and homicides. This training covers sensitivities around asking risk questions, privacy and safety, confidentiality, creating a trauma informed environment, screening and responding to disclosures and specific risk assessments relevant to individual teams. This training session also emphasises the importance of case noting and documentation when undertaking any FDV-related risk assessment.

## Webinar Event 7

### Family and Domestic Violence (FDV) Safety Planning

**Presented by:** Women's Health Strategy and Programs, North Metropolitan Health Service

**Date:** Tuesday 1 July 2025 • 10:00am – 11:00am

**Target audience:** Human service workers working with people who may be experiencing alcohol and other drug (AOD) and/or mental health (MH) issues.

Accessing AOD and/or MH services provides a port of entry for FDV safety planning, where risk is identified. This intensive one-hour session explores all key considerations when undertaking FDV safety planning. This training emphasises the importance of safety planning as a collaboration, or 'partnering', process between the practitioner and victim/survivor. This training considers safety planning for if the victim/survivor is planning to leave, or, if they are attempting to minimise risk whilst remaining with the perpetrator. We will also look at the various tools and resources to aid with safety and in collection of evidence, including key templates for safety planning. All staff are invited to join this session as we move towards becoming an FDV-informed workforce.

### Co-occurring Mental Health and AOD Issues with Young People

This webinar explores the functions of AOD use in the context of co-occurring MH issues for young people, and considerations when working with young people with co-occurring MH and AOD use concerns.

Emotion regulation is the ability to manage and respond to emotional experiences in a socially tolerable way. AOD can be one of the strategies people adopt to regulate their emotions, which may not be effective in the longer-term.

This training aims to assist the worker to:

- develop an understanding of emotion and emotion regulation
- explore the skills needed to support people to better identify, understand and manage their strong emotions
- identify strategies that will help people respond to their overwhelming emotions in constructive ways.
